



COX ENERGY AMÉRICA RATIFIES INDEPENDENT EXTERNAL AUDITOR

Mexico City, September 12th, 2022 – COX ENERGY AMÉRICA, S.A.B. DE C.V. (“Cox Energy”, “Cox Energy América” or “the Company”) (BIVA/BMV: COXA*), the first photovoltaic solar energy company to be listed on a Latin American stock exchange, announces to its shareholders and the general public that, by unanimous decision at Cox Energy América’s Board meeting held on July 26th, 2022, it was agreed to ratify the appointment of PricewaterhouseCoopers, S.C. (hereinafter “PwC” or “the Firm”) as the external auditors.

On August 30th, 2022, the Company signed an Audit engagement letter with PwC to audit Cox Energy America's consolidated financial statements for fiscal year 2022.

In compliance with article 17 of the *Circular Única de Auditores*, attached to this document you may find the certification for the non-member secretary of the Board of Directors, regarding the resolution mentioned above by which the Company’s Board of Directors approves ratifying the appointment of PwC.
