

COX ENERGY REPORTS RATIFICATION OF INDEPENDENT EXTERNAL AUDITOR

Madrid, Spain, September 21, 2023 – COX ENERGY, S.A.B. DE C.V. ("Cox Energy," "Cox," or "the Company") (BIVA/BMV: COXA*, BME: COX), In accordance with the provisions of Article 17 of Regulation (EU) No. 596/2014 on market abuse and Article 227 of the consolidated text of Law 6/2023, on Securities Markets and Investment Services (the "Securities Markets Law"), as well as Circular 3/2020 of BME Growth (the Market), we hereby inform you of the following Relevant Information regarding COX ENERGY, S.A.B. de C.V. (hereinafter "Cox" or "the Company" interchangeably), which has been prepared under the exclusive responsibility of the Company and its administrators.

Through unanimous resolutions adopted at the Cox Energy Board of Directors meeting on August 16, 2023, the Company resolved to ratify the appointment of PricewaterhouseCoopers, S.C. (hereinafter "PwC" or the "Firm") as the firm responsible for the external audit of the Company.

In this regard, on August 31, 2023, the Company entered into an Audit Engagement Letter with PwC, with the purpose of having the Firm conduct the respective audit of Cox Energy's consolidated financial statements for the fiscal year 2023.

Lastly, in compliance with Article 17 of the Single Auditors Circular, attached is the certification from the non-member secretary of the Board of Directors regarding the aforementioned resolution, whereby the Company's Board of Directors approves the ratification of PwC's appointment.
